

r.24 Lifeguarding Instructor Trainer Recertification Course Fact Sheet

Course Purpose

The purpose of the American Red Cross r. 24 Lifeguarding Instructor Trainer Recertification course is to give instructor trainers the opportunity to review the course knowledge and skills within a formal course setting to maintain their American Red Cross Lifeguarding Instructor Trainer certification. Successfully completing this course is the only method for maintaining certification as an American Red Cross Lifeguarding instructor Trainer.

Expired candidates may participate in Lifeguarding Instructor Trainer Academy.

Course Prerequisites

- Possess a current, or expired by no more than 1-year, American Red Cross Lifeguarding Instructor Trainer certification.
- Successfully complete the online session of the Lifeguarding Instructor Trainer Recertification course prior to the in-person session.

Course Length

The Lifeguarding Instructor trainer recertification course is delivered in a blended learning format, consisting of an online session (completed independently by the candidate) and in-person sessions (led by an American Red Cross–certified instructor trainer).

- The online sessions for the instructor trainer recertification course takes approximately 6-8 hours to complete. Note: the online sessions include two courses:
 - Basic-level Lifeguarding blended learning online content
 - Lifeguarding Instructor Trainer Recertification blended learning online content.
- The instruction time for the in-person session is 6 hours, 30 minutes. The instruction time does not include time for breaks or transitions. When scheduling the in-person session, additional time must be added to accommodate breaks and transitions.

Course Materials

Lifeguarding instructor trainer recertification candidates should review the following r. 24 American Red Cross course materials prior to attending the Lifeguarding Instructor Trainer Recertification course:

- Lifeguarding Instructor Trainer’s Guide (candidates should bring this manual, digital or print version, to the in-person session of the course).
- *Lifeguarding Instructor’s Manual* (candidates should bring this manual, digital or print version, to the in-person session of the course).
- *Lifeguarding Instructor’s Deck Book* (optional)

- *Lifeguarding Manual* (digital or print version)

Successful Completion

To successfully complete the Lifeguarding Instructor Trainer Recertification course, the candidate must successfully:

- Complete the basic-level Lifeguarding Blended Learning course online session.
- Complete the Lifeguarding Instructor Trainer Recertification course online session.
- Attend the entire course and participate in the in-person session.
- Complete the skill practice and polish session, demonstrating skills to the standard.
 - Entries and approaches
 - Active rescues at the surface
 - Passive rescues at the surface
 - Passive submerged rescues in shallow, moderate-depth and deep water
 - Feet-first and head-first surface dives in deep water
 - Rapid extrication using a backboard
 - Putting on gloves with wet hands
 - Two-rescuer CPR with AED for an adult
 - Surveillance and rotation procedures
 - Spinal motion restriction and extrication in shallow water
 - Multiple-Rescuer Team Response Scenarios
- Conduct one teaching assignment as part of the skill practice and polish session.
- Conduct one teaching evaluation for an instructor candidate as part of the skill practice and polish session.
- Pass the Lifeguarding Instructor Trainer Recertification Course written exam with a minimum score of 80 percent.

Certification

Candidates who successfully complete the Lifeguarding Instructor Recertification course will be issued the following American Red Cross certificate: **Lifeguarding Instructor Trainer and Lifeguarding Instructor**, valid for 2 years.

To maintain the Lifeguarding Instructor Trainer certification, the instructor trainer must successfully complete the Lifeguarding Instructor Trainer Recertification blended learning course within the 2-year certification period.

If the instructor trainer certification is expired, the instructor trainer is eligible to participate in the Lifeguarding Instructor Trainer Recertification course for up to, but no longer than, 1 year past the Lifeguarding instructor trainer certification expiration date. This 1-year grace period applies only to achieving recertification. It does not extend the instructor trainer certification and the instructor trainer may not teach courses during this time.

Instructor Trainer

To instruct the Lifeguarding Instructor Trainer Recertification course, the instructor trainer must hold a current American Red Cross Lifeguarding Instructor Trainer certification.

Course Objectives:

After completing this Lifeguarding instructor trainer recertification course, candidates will be able to:

- Understand the critical role instructors and instructor trainers have in ensuring that Red Cross–certified lifeguards have the knowledge and skills they need to be effective lifeguards.
- Identify key responsibilities of American Red Cross–certified Lifeguarding instructors and instructor trainers.
- Describe instructor actions that contribute to the quality, consistency and standardized delivery of courses in the American Red Cross Lifeguarding program.
- Demonstrate the following skills to instructor-level proficiency (demonstrate all of the skill steps as they are written, in the correct order, and in accordance with the proficiency criteria to meet the objectives of the skill):
 - Entries and approaches
 - Active rescues at the surface
 - Passive rescues at the surface
 - Passive submerged rescues in shallow, moderate-depth and deep water
 - Feet-first and head-first surface dives in deep water
 - Rapid extrication using a backboard
 - Putting on gloves with wet hands
 - Two-rescuer CPR with AED for an adult
 - Surveillance and rotation procedures
 - Spinal motion restriction and extrication in shallow water
- Demonstrate the ability to complete all critical actions; make decisions in a timely, sequential, safe and effective manner; and demonstrate skill competency in the role of **Rescuer** during Multiple-Rescuer Team Response Scenario 3—Adult Passive Submerged.
- Conduct an effective skill practice for one skill or category of skills.
- Evaluate an instructor recertification candidate’s teaching performance and facilitate a feedback session (instructor trainer recertification candidates only).
- Describe how to set up, manage and report courses taught using the American Red Cross Learning Center.
- Identify and describe the business processes to use in administering courses.
